Editorial:

When team matches for the Gold Cup, Welsh Cup and Cambria Cup are played privately, there is sometimes difficulty in settling an irregularity which requires a tournament director's ruling, as distinct from a reading and application of the law.

The WBU Rules and Ethics Committee have considered the matter and decided that the guidelines laid down in the 1986 EBU "Yellow Book" on page 11 should be followed. Fule 1 (i) and (ii) will first be applied before any such matter is deemed to have a basis on which to proceed.

Under 2. When a ruling is required the procedure is:

a) firstly the Captains may agree upon an outcome; that closes the matter. Otherwise,

b) if possible the Captains should agree upon an individual to whom they will refer the question. His ruling should be acted upon as if he were the Tournament Director. Failing this

c) obtain a ruling from any of the following:

Always provided they are not members of the competing teams.

If none of these can be contacted a ruling may be obtained from a member of the Rules and Ethics Committee;

Rules 3 and 4 apply and when there is an appeal against a ruling the matter will be referred to the WBU Rules and Ethics Committee who will determine the appeal.
